CALL TO ORDER

The Regular Meeting of the Carson City School District Board of Trustees was called to order at 7:00 p.m. by President Lynnette Conrad at Carson High School, Senator Square, 1111 N. Saliman Road, Carson City, Nevada.

SUPERINTENDENT'S REPORT

- Mr. Stokes introduced Mr. Jarod Sorum, Band Director, Carson High School and Mr. Andy Sonnemaker, Choral Director, Carson High School. Mr. Sorum recognized the students for their accomplishments at the Heritage Festival in San Francisco, California; four groups participated in the Festival, 2 choir and 2 band. The students performed very well and competed against students from schools in California, Washington, Montana and British Columbia. Carson High School received top honors; Sweepstakes of Best Music Program.
- Mr. Jon Brill, Band, Choir and Orchestra Teacher at Eagle Valley Middle School
 recognized choir students for their participation in the Nevada All-State Middle School
 Choir. The students were able to work with high class conductors, rehearse and perform
 difficult literature and perform with a 240 piece choir. The Director can choose up to; 4
 basses, 4 tenors, 2 altos and 2 sopranos. Approximately 35 middle schools from Nevada
